**Curbside Beer Sales at Casey's -** We received a letter from Casey's Corp office. The State has changed some laws back in April due to Covid. President Book will verify this. This has been tabled until next month.

**Swimming Pools** - The wording on this ordinance was changed back in 2010; ladders are to be removed if possible. This is a Zoning issue.

**Appropriations Ordinance** - Trustee Gill and Manager Shannon Risley went over the changes. This will be approved at next month's meeting. **Transformers at the High School** - The school is upgrading the electrical service. They need a new transformer that the Engineer did not figure into this project. The School had asked if the Village could help with this matter. To get the contractors in for the week is \$17,000 and the Village employees will be right there as well. Manager Shannon Risley would like to give the transformer to the school at our cost. This is tabled until next month's meeting to see what the total cost will be.

**Change in Phone Service** - The Board received a bid from Sparklight phone service. They also provide internet service for the Village Hall. We currently have Frontier for phone service. This plan would combine internet, phones, and fax lines for the Village Hall and Police Station. Would save money each month. There were some questions to how many Mbps would be needed. This will be researched and brought back next month.

**Other New Business -** The Police Dept. was recognized for all their hard work. We are fortunate to have such good officers. There was some question about billing for the recycling dumpsters. This will be checked out with the Township.
